LOS ANGELES, CA (October 30, 2006) – Step back into the ring as former heavyweight boxing champion George “Iceman” Chambers (Michael Jai White, *Getting Played*, *Spawn*) fights the battle of his life in the no-holds-barred, martial arts actioner *Undisputed II: Last Man Standing*, available on DVD January 16, 2007, from New Line Home Entertainment.
